Also present were Road Superintendent Nate Monson, Auditor Brad Solberg, and Foster County Independent Reporter Leasa Lura.

Auditor Solberg asked the BOCC to approve a lost check affidavit for Office Depot. Commissioner Hagel made a motion to approve the lost check affidavit for Office Depot, seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner Hagel asked to add Social Service District under Old Business. Commissioner Utke made a motion to approve the agenda with additions, seconded by Commissioner Scanson. All voted aye and the motion passed.

Old Business

Commissioner Hagel wanted to mention to the BOCC that Chris Jones at the State approved the Central Prairie Social Service District. Hagel stated that the Board Structure will be three from Wells County, two from Foster County, and two from Eddy County.

New Business

Public Health Nurse Lisa Hilbert approached the BOCC about a project that is being planned for the Public Health Building. The building committee met with Lisa Hilbert and Custodian Russ Heidt about quotes that have been received for an expansion project in the public health office. The building committee made a recommendation to go

with part of project one and part of project two awarding Tim Carr with the labor, Randy's Electric for electric work including LED lighting, and Central City Lumber supply the supplies. Commissioner Utke made a motion to accept the recommendation from the Building Committee for the public health office, seconded by Commissioner Hagel. All voted aye and the motion passed.

Auditor Brad Solberg brought a contract from the North Dakota Association of Counties (NDACo) for the rewriting of the Foster County Policy Manual. Commissioner Hagel made a motion to approve and sign the contract from NDACo, seconded by Commissioner Scanson. All voted aye and the motion passed.

Road Superintendent Nate Monson told the BOCC that the Road Department has purchased a 2008 Ford F350 long box with 80,000 miles for \$13,600. Monson also stated that he has a sheet ready to discuss with townships during the township meetings on November 26th. Monson finished off with going over his township sheet.

Auditor Solberg received a letter from the NDDOT about doing traffic counts in the county. NDDOT will be out on their highways and stated that Foster County would have up to 12 spots to have counts done. Commissioner Scanson mentioned the Club Hall Road and that Solberg and Monson should come up with a map and bring it to the next meeting.

Emergency Manager Jess Earle asked the BOCC via email to rescind the burn ban. Commissioner Scanson made a motion to rescind the current burn ban, seconded by Commissioner Utke. All voted aye and the motion passed.
