PROCEEDINGS OF THE FOSTER COUNTY BOARD OF COMMISSIONERS August 4th, 2020

At 3:30pm, Chairman David Utke called the Foster County Commission meeting to order. Roll call included Commissioner Alan Scanson, Commissioner Becky Hagel, Commissioner Pat Copenhaver, Commissioner David Utke and Commissioner Scott Beumer. Also present were Road Superintendent Nate Monson, Auditor Brad Solberg, States Attorney Kara Brinster, and Foster County Independent Reporter Leasa Lura.

The meeting began with approval of the minutes. Commissioner Scanson made a motion to approve the minutes of the July 21st, 2020 meeting, seconded by Commissioner Hagel. All voted aye and the motion passed.

Commissioner Hagel made a motion to approve the bills, seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner Scanson made a motion to approve the agenda, seconded by Commissioner Beumer. All voted aye and the motion passed.

Old Business

Discussion was had on the County Gravel Pit. Auditor Solberg stated that his office is looking into the deed as it came from University of School Lands.

New Business

Nate Monson, Road Superintendent provided an update sheet to the BOCC. Monson stated in the sheet that there were no major repairs needed. Monson stated that the blade patch on the Murphy Road will done in Mid-August.

Wold Engineering Engineer Mike Rivinius reviewed the 3 stream crossing studies presented to the BOCC at the previous meeting. Rivinius recommended to appeal sites 2 and 3. There are questions on the methods used to determine the CFS on those spots. Commissioner Utke asked how an appeal would start. Rivinius told Utke that he would need to talk to the States Attorney to go through an appeal. Commissioner Scanson stated that the BOCC asked Wold Engineering to review this information and bring back recommendations. Commissioner Scanson made a motion to appeal Sites 2 and 3, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Auditor Brad Solberg stated that the BOCC will need to start thinking about redistricting. This happens every 10 years following the Census.

Tobacco Coordinator Colleen Sweet approached the BOCC about making Foster County Parks tobacco free. Commissioner Beumer made a motion to make all Foster County Parks Tobacco Free Zones, seconded by Commissioner Hagel. All voted aye and the motion passed.

Public Health Nurse Lisa Hilbert brought quotes for a trailer to the BOCC. Commissioner Beumer made a motion to allow Public Health to spend up to \$15,873.75 for a trailer, seconded by Commissioner Hagel. All voted aye and the motion passed.

Hilbert told the BOCC that Public Health will now be administering COVID-19 tests, and that they will need more hours from Cassie Ness. Commissioner Beumer made a motion to add more hours for COVID-19 testing, with staying under 20 hours a week, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Hilbert told the BOCC that at the mass testing, they tested 300 people. Hilbert recommend the wearing of masks, social distancing, and not taking breaks together in the Courthouse.

Solberg presented the final contract for the Cornice Project to the BOCC. Commissioner Copenhaver made a motion to approve the contract with General Roofing and Construction, seconded by Commissioner Scanson. All voted aye and the motion passed.

With no further business, Commissioner Utke adjourned the meeting at 6:32pm.
