PROCEEDINGS OF THE FOSTER COUNTY BOARD OF COMMISSIONERS

December 1st, 2020

At 3:30pm, Chairman Utke called the Foster County Commission meeting to order. Roll call included Commissioner Alan Scanson, Commissioner Becky Hagel, Commissioner Pat Copenhaver, Commissioner David Utke, and Commissioner Scott Beumer. Also present were Auditor Brad Solberg, States Attorney Kara Brinster, and Foster County Independent Reporter Leasa Lura.

The meeting began with approval of the minutes. Commissioner Scanson made a motion to approve the minutes of the November 17th, 2020 meeting, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Commissioner Hagel made a motion to approve the bills, seconded by Commissioner Copenhaver. All voted aye and the motion passed. Auditor Solberg stated that Foster County has spent \$3,442,152.29 this year and have taken in \$3,876,033.49. Solberg mentioned that the BOCC just approved to spend \$100,000.00 and still have to finalize paying the two building projects. Solberg mentioned that the BOCC is on pace to break even this year.

Discussion was had on the County Gravel Pit. States Attorney Brinster stated that BOCC has an easement on the gravel pit, not ownership.

New Business

Nate Monson, Road Superintendent provided an updated sheet to the BOCC. It explained that there were no major repairs on any equipment. Monson's sheet mentioned that all culverts are in for Site 1, 2, and 3 on the Bordulac Road. It also mentioned that the road crew plans on burning the tree pile at Juanita Lake when there gets to be a bit more moisture.

Sheriff Justin Johnson approached the BOCC about an open position in his office. Johnson stated that Deputy Thomas will be done working on January 20th, 2021. Commissioner Copenhaver made a motion to start advertising for the open position, seconded by Commissioner Scanson. All voted aye and the motion passed.

The BOCC went over their goal sheet. Commissioner Utke asked all commissioners to go through the list and add or subtract to get it updated.

Auditor Solberg and Commissioner Utke gave a few ideas on how to make meetings more efficient for the Board. Solberg asked the commissioners if they would like nd.gov email addresses for their work email. Commissioner Hagel thought that would be a good idea, as it keeps work and personal separate. Solberg is looking into a few more ways to make the meetings run more smoothly.

Commissioner Hagel told the BOCC that she would like to update the wording in Sick Leave policy to make it match the practice of Foster County.
