## PROCEEDINGS OF THE FOSTER COUNTY BOARD OF COMMISSIONERS

October 19th, 2021

At 3:30pm, Chairman Hagel called the Foster County Commission meeting to order. Roll call included Commissioner Alan Scanson, Commissioner Becky Hagel, Commissioner David Utke, and Commissioner Scott Beumer. Also, present were Auditor Brad Solberg, Road Superintendent Nate Monson, and Foster County Independent Reporter Leasa Lura.

The meeting began with approval of the minutes. Commissioner Utke made a motion to approve the minutes of the October 7<sup>th</sup>, 2021, regular meeting seconded by Commissioner Scanson. All voted aye and the motion passed.

## New Business

Nate Monson, Road Superintendent, approached the BOCC with an update from the Road Department. Monson stated that there were no major repairs since the last meeting. Monson stated that the lines were painted on the County Highways. Monson finally stated that the Road Department is getting ready for winter in the coming weeks.

Estabrook Township presented a bill to the BOCC for share road gravel for \$233.62. Commissioner Scanson made a motion to approve the project, seconded by Commissioner Beumer. All voted aye and the motion passed.

NDSU Extension Agent Jeff Gale presented Lead Local training to the BOCC. Gale asked if the BOCC would be willing to cover the \$75 fee for employees to attend. Commissioner Utke made a motion to approve paying \$75/employee registration fee for Lead Local, seconded by Commissioner Scanson. All voted aye and the motion passed.

Lisa Hilbert, Public Health Administrator, presented a trailer storage option to the BOCC. This storage would be through Donald Bickett. The BOCC asked if Hilbert could get a contract from Mr. Bickett before they made any motions. Hilbert also brought a Notice of Grant award to the BOCC for approval. The NGA was for an increase in Funding for Epidemiology and Laboratory Capacity for Infection Disease. Commissioner Beumer made a motion to approve the NGA, seconded by Commissioner Utke. All voted aye and the motion passed.

Auditor Solberg stated that the BOCC needed to set minimum sales prices on the three foreclosed properties in Foster County. Solberg presented the amounts that would cover the outstanding taxes and a estimate for the next year:

Parcel-02922000 for \$400 Parcel-02845000 for \$3,200 Parcel-03972000 for \$70

Commissioner Scanson made a motion to approve the amounts for the foreclosure properties, seconded by Commissioner Beumer. All voted aye and the motion passed.

Commissioner Hagel presented the NDDOT Maintenance Agreement to the BOCC. Commissioner Beumer made a motion to approve the Maintenance Agreement from the NDDOT, seconded by Commissioner Scanson. All voted aye and the motion passed.

Commissioner Utke asked if the BOCC should extend their deadline to approve total amount for the Township Road Discount Program until November  $2^{nd}$ , 2021. Commissioner made a motion to extend the deadline until November  $2^{nd}$ , 2021, seconded by Commissioner Scanson. All voted aye and the motion passed.

With no further business, Commissioner Hagel adjourned the meeting at 4:51pm.
