## PROCEEDINGS OF THE FOSTER COUNTY BOARD OF COMMISSIONERS June 4<sup>th</sup>, 2019

At 3:30pm, Chairman Alan Scanson called the Foster County Commission meeting to order. Roll call included Commissioner Alan Scanson, Commissioner David Utke, Commissioner Becky Hagel and Commissioner Pat Copenhaver. Also present were Road Superintendent Nate Monson, Auditor Brad Solberg, States Attorney Kara Brinster and Foster County Independent Reporter Leasa Lura.

The meeting began with approval of the minutes. Commissioner Copenhaver made a motion to approve the minutes of the May 21st, 2019 meeting, seconded by Commissioner Utke. All voted aye and the motion passed.

Commissioner Copenhaver made a motion to approve the bills, seconded by Commissioner Hagel. All voted aye and the motion passed.

Commissioner Utke requested to add Juanita Lake Park under goals. Commissioner Utke made a motion to approve the agenda, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

## Old Business

Commissioner Hagel stated that she spoke with Emergency Manager Jess Earle and said that she will need to be moved by July 1<sup>st</sup>, 2019.

Auditor Solberg presented a resolution to form a Carrington/Foster County Complete Count Committee. Commissioner Hagel made a resolution to join the Carrington/Foster County Complete Count Committee, seconded by Commissioner Utke. All voted aye and the motion passed.

## New Business

Nate Monson, Road Superintendent, told the BOCC that there are no roads closed in Foster County. Monson informed the BOCC that load restrictions were taken off on June 3<sup>rd</sup>, 2019.

Wold Engineering's Mike Rivinius stated that he and Monson met with Asphtech about the chipping project. Asphtech stated that the time frame for work was June 14<sup>th</sup>-June 18<sup>th</sup>.

Monson informed the BOCC that the Road Department intends to sickle mow the ditches starting June 24<sup>th</sup>. Commissioner Copenhaver stated that he would ride with Monson and Rivinius to inspect encroachment on County Highways.

At 3:59pm Chairman Scanson suspended the regular commissioner meeting for the Board of Equalization meeting, At 4:00pm Chairman Scanson called the Foster County Board of Equalization (BOE) meeting to order.

Tax Director Karen Evans brought the sales ratio report to the BOE for review. Evans stated there was a 5% decrease in commercial Property value, and decrease of 6% in residential property value, and an increase of 2% on ag land. Commissioner Utke made a motion to accept the values for Foster County, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

At 4:22pm Chairman Scanson moved to adjourn the BOE meeting. At 4:23pm Chairman Scanson called to resume the regular meeting of the Foster County Commissioners

Auditor Solberg asked the BOCC if they had any other changes that they would want to add to the policy manual update. Commissioner Utke asked if we need to add weather closures to the policy manual. Utke also asked if Performance Evaluations would be added. Solberg stated that they would ask to have those both added. Solberg asked each Commissioner to look through the manual again to see if they have any other changes and bring to the next regular meeting.

Commissioner Hagel stated that she met with Ron Wiederholt about the open extension agent position. Hagel stated that the BOCC would like to have an emphasis on 4-H. The BOCC is waiting for NDSU to approve the new job description.

Commissioner Copenhaver stated that he had spoken with Carrington Hospital Administrator about potential Doctor's coming to Carrington. Copenhaver stated that two potential candidates would be coming in the coming months and asked the BOCC to come and meet and greet. Commissioner Utke asked how a government board would contribute. Brinster stated that she was not sure if Commissioners would be a deciding factor to attract a Doctor.

Commissioner Utke asked each of the Commissioners to look through the sheets he provided for rules and regulations for Juanita Lake Park. Utke stated that he would like to get this information to Jeff Golz. Auditor Solberg stated that his office will create a log-in sheet for the Park to more accurately track how long people stay.
