Also present were Road Superintendent Nate Monson, Auditor Brad Solberg, and Foster County Independent Reporter Leasa Lura.

The meeting began with approval of the minutes. Commissioner Hagel made a motion to approve the minutes of the July 16th, 2019 meeting, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Commissioner Hagel made a motion to approve the lost Check Affidavit for Credit Collections Bureau, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Auditor Solberg asked to add the door locks and ID printer to the agenda, and the sale to the agenda. Commissioner Utke asked to add the public health building to the agenda. Commissioner Beumer made a motion to approve the agenda, seconded by Commissioner Utke. All voted aye and the motion passed.

Old Business

Auditor Solberg stated that EM Earle has moved into her office on the 2nd floor. Commissioner Hagel stated that she will request to bring the FEMA records to the courthouse.

New Business

Nate Monson, Road Superintendent, told the BOCC that the Road Department has durapatched fifteen spots since the last meeting. Monson stated that the road department has been mainly blading roads and fixing and putting up signs. Monson mentioned to the BOCC that Wold Engineering had a pre-start meeting with the contractor for the Miller Bridge Project. They plan on starting August 12th and finish before November 1st.

Auditor Solberg received an email from the NDACo about Foster County's voting delegate for the state NDACo Convention. Commissioner Hagel made a motion to name Auditor Brad Solberg as the NDACo Delegate, seconded by Commissioner Beumer. All voted aye and the motion passed.

Auditor Solberg presented a termination letter for the JPA with Eddy County for the services of Emergency Management. Commissioner Beumer made a motion to approve the JPA Termination Letter, seconded by Commissioner Utke. All voted aye and the motion passed.

Auditor Solberg asked that his office oversee the Door locks and the ID printer going forward.

Auditor Solberg told the BOCC that there are only three items for the County Sale and would like to have a closed bid sale.

Shane Wendel and Lisa Hilbert approached the BOCC about letting Central Clinic use the Public Health building for treating opioid abuse disorders. Wendel explained how the process works. Wendel then told the BOCC that they have currently outgrown their current facilities. Commissioner Hagel made a motion to allow Central Clinic to use the Public Health building for \$1 for six months and will come back to re-evaluate after the six months, seconded by Commissioner Copenhaver. All voted aye and the motion passed.

Emergency Manager Jess Earle approached the BOCC about getting the City of Glenfield a new Siren. Earle stated that the City of Glenfield would like to use the 911 funds to help pay for the Siren. Commissioner Hagel stated that they have just received information about a USDA Rural Development Grant. Hagel stated that this grant may help both the City of Glenfield and Foster County save money. Auditor Solberg stated that he would look into the USDA grant and report back at the next Commissioner Meeting.

Commissioner Utke stated to the BOCC that the Building Committee received one quote for the Public Health building project, and it was for \$15,500. That was about double what the building committee expected so they recommended not doing the project this year. The Building committee stated that maybe they should contact the concrete contractors to look at doing part of the project. Utke also mentioned that the building committee stated that they recommend the next project around the courthouse be fixing the cornice around the top of the building.

With no further business, Chairman Scanson moved to adjourn the meeting at 5:32pm.
